








CPA & PSP & Areas

- Competent pilotage authority (CPA) = TraFi
- Pilotage service provider (PSP) = Finnpilot Pilotage Ltd
 - According to the pilotage act it is compulsory to provide pilotage service for fairways listed in Trafi's order of "Compolsory pilotage areas and pilot boarding areas" (TRAFI/6793/03.04.01.00/2011).
 - Six pilotage areas, more than 1000 pilotage fairways, 148 pilots altogether (2014):
 - Bay of Bothnia
 - Sea of Bothnia
 - Archipelago Sea
 - Helsinki
 - Kotka
 - Saimaa (Lake area)









Record of Piloted miles






Pilot licences, PECs & Exemptions year 2014



- Trafi has issued during the year 2014:
 - 25 new pilot licenses
 - 37 pilot licenses renewed
 - New fairway(s) has been added to 16 pilot licences
 - 80 new PECs
 - 57 PECs renewed
 - New fairway has been added to 13 PECs
 - 15 new Exemptions
 - 18 exemptions renewed
 - New area/ship added to 1 exemption


Handled total year 2014: 78 Pilot licenses, 150 PECs, 34 Exemptions



Legislation exercise



- Pilotage act (940/2003) under review:
 - Definitions of different areas of internal waters
 - Some conditions for compulsory pilotage reviewed
 - Requirements for education providers clarified
 - Small LNG bunkertankers exempted from compulsory pilotage
 - Consequently Government Decree on Pilotage (246/2011)will be renewed
 - Trafi's Regulations on Training, examination and practical pilotage assessment required for issue of Pilot Licences, Pilot Exemption Certificates and Exemptions (TRAFI/6798/03.04.01.00/2011) will be changed accordingly
 - Trafi's Regulation on Compulsory pilotage areas and pilot boarding areas (TRAFI/6793/03.04.01.00/2011) under review
 - Project of the Finnish Transport Agency for registration of fairways
 - Some applications from Finnpilot and Finnish Transport Agency
 - New legislation in force from 1.1.2016
